

Seeking the Adults and Children Held by James Thomas, Jr.

Ongoing research is further detailing the lives of those who were enslaved directly by James Thomas, Jr. and those held by him though the leasing system known as slave hiring. The preliminary information below has been provided to facilitate the work of those conducting genealogical research, and it will be updated as new material is added.

Many individuals' names appear in multiple documents and those sources have been consolidated in their entries. When there is reasonable certainty that a slight name variation indicates the same person, the variation is noted. In the cases of multiple appearances of a common first name (examples: George, Jerry, William), details such as former/current enslavers' names, designations applied by enslavers (Old, Little, Aunt), location, and circumstances are used to determine separations and groupings. When there is no clarifying information, each appearance is given a separate entry pending additional documentation.

This list currently contains 415 entries. Additionally, six children whose names were not recorded appear in the entries of their mothers. Of the 421 total, it is estimated that up to 39 could correspond to individuals named in other entries.

Notes

- While numerous last names are included in collected resources and some may have been individuals' actual surnames, in some cases Thomas applied enslavers' last names to those he leased.
- 2. Because many last names were not recorded, this list is alphabetized by full available name.
